1. As per the provision under Section 65 (4) of Maharashtra University of Health Sciences Act, 1998, I am directed to communicate the decision of the Academic Council taken in its meeting held on 27/05/2019. The Academic Council has unanimously resolved vide its resolution No. 57/2019 to grant Continuation / Extension of affiliation to the B.P.Th. course of your college for the academic year 2019-2020 subject to following conditions:

- The intake capacity shall be 40
- As per grant of permission from State Government (as applicable).
- Fulfillment of following **deficiencies** and submission of its compliance report within **Three Months** from the date of issuance of this letter:

4. Colleges are required to carryout Permanent approval process of the Teachers who have been granted temporary approval upto 31<sup>st</sup> July 2019.
5. To update Academic Online Teacher's Database of all teachers. On monthly basis review of availability of teachers shall be taken at College level & it shall be kept updated.
5. Adequate facilities regarding Hostel and Library to be provided to the students.
6. You are requested to comply with the above mentioned deficiencies within a stipulated time without fail and submit compliance report.
7. Kindly note the above and do the needful scrupulously.

- 1) Although the Continuation / Extension of Affiliation is granted to your College for the Academic Year 2019-2020, you are not allowed to admit students for First Year BPTH Course without receipt of permission from State Government (As Applicable).
- 2) The Dean / Principal of the College is hereby instructed to submit letter of permission from State Government (As Applicable)..
- 3) In case of any irregular admissions, University shall not be responsible for any academic or pecuniary loss or damages of the concerned.
